## INTRODUCTION

The FBiH Government adopted the proposal project *Development of Industrial Policy in the Federation of BiH*, as an integral part of the Economic Development Strategy of the Federation of BiH, at its 136<sup>th</sup> session held on 8 March 2010. At the session of the Economic and Social Council for the territory of the Federation of BiH, held on 27 April 2010, the Economic and Social Council supported the document *Development of Industrial Policy in the Federation of Bosnia and Herzegovina*, assessing that it provided a cross-section of the industry and that it was very important for the adoption of future Action plans. The House of Representatives of the Parliament of the FBiH adopted the proposal of this project at its session held on 11 May 2010. The House of Peoples of the Parliament of the FBiH adopted the document *Proposal of the Industrial Policy Development Project in the Federation of BiH* at the session held on 22 June 2010.

The conclusions on the adopted document were published in the Official Gazette of the Federation BiH, No. 40/10.

After the adoption of the Project, at its 155<sup>th</sup> session, held on 26 August 2010, the FBiH Government adopted the Decision on the appointment of Working Group consisting of representatives of ten FBiH ministries, the Confederation of Independent Trade Unions of BiH and the FBiH Privatization Agency to prepare the Action Plan for implementation of the project *Industrial Policy Development in the Federation of Bosnia and Herzegovina* (Official Gazette of the Federation of BiH, No. 59/10).

The Action Plan was adopted at the 12<sup>th</sup> session of the FBiH Government held on 5 July 2011 in Sarajevo.

The Action Plan defines 10 priorities, 20 measures and 87 Lawivities. The objective, measurable performance indicators, holder of Activity, implementation deadlines and institutions responsible for implementation are defined for each Activity, and the FBiH Ministry of Energy, Mining and Industry regularly monitors, analyses and submits reports to the FBiH Government on the implementation of the Action Plan Lawivities.

At its 49<sup>th</sup> session held on 10 May 2012, the FBiH Government adopted the Report of the FBiH Ministry of Energy, Mining and Industry on the implementation of the Action Plan for implementation of the project *Industrial Policy Development in the FBiH* for the period July-December 2011. At its 30<sup>th</sup> emergency session held on 20 June 2013, the FBiH Government adopted the Report on implementation of the Action Plan for implementation of the project *Industrial Policy Development in the Federation of BiH* for 2012, and adopted the Conclusion V. No. 577/2103 of 20 June 2013 based on which the FBiH Ministry of Energy, Mining and Industry initiates Lawivities for amendments to the Action Plan for the Implementation of the Project *Industrial Policy Development in the Federation of BiH* 2011-2015.

Namely, while monitoring the implementation of the Action Plan Lawivities, certain problems and/or challenges and obstacles related to the implementation of the Action Plan were identified, and some holders of certain Lawivities submitted the proposals of amendments to the Action Plan during their reporting. The decision of the FBiH Government No. 1151/2013 of 23 October 2013 appointed the Working Group consisting of the representatives of ten FBiH ministries, the FBiH Civil Protection Administration, the FBiH Administration for Inspection Affairs, the Confederation of Independent Trade Unions of BiH and the FBiH Privatization Agency to prepare the amendments to the Action Plan for implementation of *Industrial Policy Development Federation of BiH* 2011-2015. According to point II of the Decision (Official Gazette of the FBiH, No. 86/13), the amendments to the Action Plan were made, so that the consolidated text of the Amendments to the Action Plan contains 10 priorities, 20 measures and 109 Lawivities. The Amendments to the Action Plan were adopted at the 94<sup>th</sup> session of the FBiH Government held on 9 January 2014; Conclusion V No. 7/2014 (Official Gazette of the FBiH, No. 4/14).
